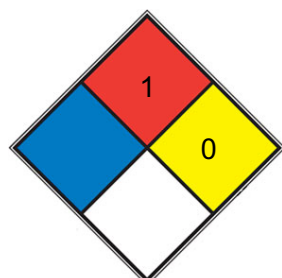

##### Eye/face protection
