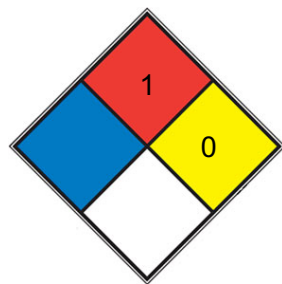

### Waste treatment methods
