## SECTION 4: First aid measures

### **Description of first aid measures**

#### **If inhaled**

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately.

Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

Excess naltrexone ingestion may be treated with ... activated charcoal and cathartics. No antidote to naltrexone overdose is available. Supportive care is the mainstay of treatment, and may include oxygen, intravenous fluids, and vasopressors.

**Personal precautions, protective equipment and emergency procedures**

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

### **Bioaccumulative potential**

An estimated BCF of 8.6 was calculated in fish for naltrexone(SRC), using a log Kow of 1.92(1) and a regression-derived equation(2).

According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is low(SRC).

### **Mobility in soil**

Using a structure estimation method based on molecular connectivity indices(1), the Koc of naltrexone can be estimated to be 1000(SRC).

According to a classification scheme(2), this estimated Koc value suggests that naltrexone is expected to have low mobility in soil. The pKa1 (for the proton on the nitrogen) of naltrexone is 8.38, and pKa2 (for the phenolic hydrogen) is 9.93(3), indicating that this compound will almost entirely exist in cation form in the environment and cations generally adsorb more strongly to soils containing organic carbon and clay than their neutral counterparts(4).

### Disposal methods

#### Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

#### Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
