#### If inhaled

Immediate first aid: Ensure that adequate decontamination has been carried out. 

# SECTION 6: Accidental release measures

#### Personal precautions, protective equipment and emergency procedures

#### Mobility in soil

Using a structure estimation method based on molecular connectivity indices(1), the Koc of protopine can be estimated to be 1.2X10+4(SRC). According to a classification scheme(2), this estimated Koc value suggests that protopine is expected to be immobile in soil. The estimated pKa of protopine is 4.95(3), indicating that this compound will exist partially in the cation form in the environment and cations generally adsorb more strongly to soils containing organic carbon and clay than their neutral counterparts(4).

#### **Disposal methods**

#### Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

#### Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
